Club Seal Program for Junior Clubs in Florida



GOLD SEAL REQUIREMENTS

1. Pay a \$100 annual fee (one-time)
2. Provide proof of valid Florida business license and/or registration
3. Provide proof of registration with IRS
4. Provide certification of filing a previous year's tax return for the club with the IRS
5. Provide proof of D&O insurance (or equivalent) - For Non-Profits Only!
6. Club Director must attend the annual Junior Forum meeting
7. Club Director must live in Florida and be a member of the Florida Region
8. Club will ensure that all youth/junior volleyball coaches in their club register with USAV and pass a USAV background screen prior to participating with any athletes
9. Club will ensure that all youth/junior coaches are USAV IMPACT certified at a minimum
10. Must comply with the Club Director Code of Ethics
11. Must post the Spectator/Parent Code of Conduct in all practice facilities
12. Club must have a published Handbook and provide an electronic copy to the Florida Region
13. Club Handbook must have a dispute resolution and refund policy at a minimum
14. Club Website must have the harassment policy posted on the Home Page
15. **Not have any Incident Review findings against the club for a two year period**
16. **Not have received any Notices of Infraction for a two year period**
17. Not be on probation or suspension (Club or Club Director)

GOLD SEAL BENEFITS

1. Club will be able to post the Gold Seal logo on the club website and any/all club literature during the year it is applicable
2. Gold Seal will be posted on the Indoor Jr. Club Directory page next to the club's name



SILVER SEAL REQUIREMENTS

1. Pay a \$100 annual fee (one-time)
2. Provide proof of valid Florida business license and/or registration
3. Provide proof of registration with IRS
4. Provide certification of filing a previous year's tax return for the club with the IRS
5. Provide proof of D&O insurance (or equivalent) - For Non-Profits Only!
