

## **Think Outside the Gym Equipment Loan Program Agreement**

The agreement ("Agreement") is by and between the Florida Region of USA Volleyball, Inc. ("Region") and \_\_\_\_\_ ("Club") for the participation in the Region Think Outside the Gym Equipment Loan Program. The purpose of this program is to provide the Club with the equipment necessary to organize and execute portable club volleyball activities within their community.

As a participant in the Think Outside the Gym Equipment Loan Program, the Region understands and agrees to the following conditions;

- A. The Region will ship Portable Grass Volleyball Net System to address provided. Region will cover initial shipping costs.
- B. The Region retains full ownership rights of the equipment provided and,
  - 1. May request that the equipment be made available for the Region's exclusive use at events it deems necessary;
  - 2. May require the return of the equipment in emergency situations within 5 business days, with the express understanding that Club will cover any return shipping cost.

Upon execution of this Agreement by both parties, the Region will provide Club with one full Portable Grass Volleyball Net System (Detailed list provided in Exhibit A). Upon receipt of the portable grass volleyball net system on loan, Club agrees to

- A. Inventory equipment and notify Region within 24 hours of receipt if anything is damaged or missing.
- B. Store and maintain the equipment in full working order at own cost;
- C. Repair any damage to the equipment at own cost, reasonable wear and tear excluded, and notify the Region of any such damage before repairs are made;
- D. Replace any equipment that is unable to be repaired or lost at own cost, by contacting the Region to coordinate equipment replacement;
- E. Ship the equipment to the Region at 15010 US HWY 441 Eustis, FL 32726 to be delivered no later than August 31, 2020 with the express understanding that Club will cover return shipping cost.

The term of this Agreement shall commence upon execution by both parties and continue through August 31, 2020, unless renewed or unless earlier terminated by the Region at its sole discretion. The Agreement shall be construed in accordance with the terms and conditions set forth in this Agreement, and the law of the State of Florida, without regard to choice or conflict of law principles that would cause the application of any other law.



## **Exhibit A**

### Think Outside the Gym Equipment List

Equipment being provided includes:

Name of System: High Strength Recreation Set: RS

- **Recreational Net** – 32 feet (w) x 39 inches (h). Constructed of #18 nylon netting and 2-inch 13 oz top tape. Nylon cords through top and bottom of net that attaches net to poles.
- **2-Piece Adjustable Aluminum Poles** – Lighter poles weighing only 4lbs each compared to the past heavier steel poles. 2-inch OD that can adjust to heights for men's, women's and co-ed. Each pole has eyebolts on both sides to connect carabiner clips (optional).
- **Rope Boundary Lines** - Pre-measured quarter inch rope boundary lines with loops in each corner for grass stakes. Measures to 30' x 60' and includes a hand winder.
- **(2) Rope Guywire Sets** - Each set comes with tension adjustment handles and chain links for ground stakes to add tension to the net
- **(4) Steel Ground Stakes** – Low profile headed ground stakes which connect to guywire chain links. Pounded below ground to avoid player injuries.
- **Carrying Bag** - Durable carrying case measuring 60" x 8" x 8" with handles, full length double zipper with space for a ball
